Annual Reporting Requirements

The Council on Education for Public Health (CEPH) is a private non-profit corporation established in 1974 by the American Public Health Association (APHA) and the Association of Schools of Public Health, now known as the Association of Schools and Programs of Public Health (ASPPH). The articles of incorporation were adopted by the two associations, which became the original corporate members of the new organization. The articles specified CEPH's purposes as follows:

- (a) Improving the quality of education in public health schools, institutions, and programs through accreditation, certification, approval, and related activities which publicly attest compliance with defined standards; including particularly the accreditation of graduate schools of public health.
- (b) Otherwise encouraging improvement in the quality of education in public health through conduct of research, provision of consultation, distribution of publications, support of demonstrations, definition of standards, development of sanctions, sponsoring of examinations, and other appropriate means related to accreditation, certification, and approval activities.
- (c) Assuring an independent mechanism for the conduct of these accreditation and related activities under joint sponsorship of professional and educational organizations comprising the corporation membership.

The articles of incorporation ascribed broad powers and responsibilities to the governing body of the newly established organization. One of the obligations specified in the charter was a requirement that CEPH annually call a meeting of the corporation membership at which duly designated representatives of those organizations would meet with the Council to receive its annual report. This report, which reviews the activities of calendar year 2019, is submitted in response to that requirement.

About CEPH

The Council on Education for Public Health is a private, non-profit corporation chartered under provisions of the District of Columbia Non-Profit Corporations Act. It is recognized by the Internal Revenue Service as a 501(c)(3) organization and by the State of Maryland as an organization exempt from local income and sales taxes. No organizational or structural changes took place during 2019 that would affect this status.

Achieving our mission of assuring quality education in public health is only possible with the support of our many partners. The Council would also like to thank its dedicated volunteers who contribute countless hours to the accreditation process.

Board of Councilors

The articles of incorporation establish a 10-member Board of Councilors as the governing body of CEPH. Members of the governing body are appointed either singly or jointly by the two corporate members.

APHA appoints three members to the Council, and those representatives are expected during their tenure as councilors to be "primarily involved in the practice of public health or in the conduct of related health services."

ASPPH appoints three members, and its delegates are to be "drawn from the faculty, administration or student body of schools of public health."

The remaining four councilors are jointly appointed by the corporate members on the recommendation of the CEPH governing body.

Two of these positions represent the interests and concerns of the general public; public members may not be employed by an academic institution that has a school or program of public health. The remaining two positions represent the programs accredited by CEPH. These candidates are nominated after broad solicitation of relevant organizations. 2019 Council Meetings

Regular business meetings engage the councilors in accreditation-related actions—accreditation reviews, interim reports, substantive change notices—and policy-related matters such as the adoption of criteria, policies, procedures, and internal practices. The Council also provides financial oversight for the agency. The Council conducted four business meetings in 2019.

In 2019, the major work of the Council focused on the continued implementation of the 2016 Accreditation Criteria for Schools and Programs and the 2018 Accreditation Criteria for Standalone Baccalaureate Programs, and adopting its 2019-2024 strategic plan.

The Executive Committee met four times in 2019 either via conference call or face-to-face in conjunction with Council meetings. The committee functions as a finance committee; it performs regular monitoring of CEPH financial matters, adopts annual fee schedules, and initially reviews and assists with budget development. The Executive Committee is empowered to act for the Council between regular CEPH meetings; it considers substantive change notices and other routine accreditation-related business, freeing the Council meetings for discussion of substantive matters. At its December 2019 meeting, the full Council elected, by secret ballot, the officers who will serve on the Executive Committee in 2020.

Strategic Planning Committee

The Strategic Planning Committee consisted of Ms.







Joyce Gaufin, Ms. Tiffany Hill, and Ms. Ruth Gaare-Bernheim. In 2019, the committee continued to develop its 2019-2024 strategic plan. In 2019, she managed the development and implementation of the Accreditation & Education Forum.

Their duties include conducting consultation visits with schools and programs and leading CEPH initiatives in addition to managing the accreditation review process and serving as on-site coordinators for accreditation visits.

Accreditation Specialists Alexandra DiOrio, MPH, Zeinab Bazzi, MPH, and Accreditation Coordinators Emily Albers, MPH and Julia Konner, MPH, carry out tasks to ensure that the accreditation review process for

schools and programs proceeds smoothly. Their duties include managing the accreditation review process, serving as on-site coordinators for accreditation site visits, editing and preparing sections of the site visit team reports, developing training materials, conducting training sessions, and responding to stakeholder inquiries.

Chelsea Principio serves as the Office Administrator for CEPH. Chelsea supports the financial operations of CEPH, such as processing invoices for schools and programs and reimbursable expenses for site visitors.

Sources of Financial Support

The Council's income derives from a combination of contributions and fees. During 2019, APHA contributed \$102,397 in unrestricted funds to CEPH. Accredited schools of public health, public health programs, and standalone baccalaureate programs paid approximately \$1,096,056 in annual fees. Additional fees are charged when a school or program undergoes its periodic reevaluation, begins the applicant process, or seeks consultation. Total revenues during 2019 from contributions, fees for specific services, interest, and miscellaneous sources amounted to \$1,835,360 (including reimbursement for travel expenses of site visitors and consultants).

Budgeting and Financial Planning

The Council adopted a budget for calendar year 2019 in the amount of \$1,634,434. Budget planning takes into account anticipated review workloads and expected inflation, as well as the organization's policy about maintaining reserves. Actual income for the year was slightly higher than projected at \$1,835,340. Actual expenditures for the year were slightly lower than budgeted,


approximately \$1,554,525 (including travel reimbursements). CEPH ended the year with approximately \$1,100,000 in cash reserves amounting to approximately 67% of the operating expenses for the year. The Council follows a policy of maintaining reserves equal to at least six months of operating expenses.

The APHA Executive Board approved a new funding agreement for July 1, 2019 to June 30, 2020 of \$104,167.

Each summer, the CEPH Executive Committee establishes a fee schedule that will be applicable for the following year. The annual support fees for accredited schools and programs increased slightly for 2020. Applicant, accreditation, and consultation fees remained the same as the previous year.

Audit of CEPH Accounts

The accounting firm of Neuman, Pollack and Associates, P.A. was retained to conduct an independent audit of CEPH's financial records for 2019. A copy of the audited financial statement is a part of this annual report to the corporate members.



In 2019, CEPH offered a range of live, synchronous training and technical assistance events available in place-based and online formats.

As of December 31, 2019, CEPH accredited a total of 210 units: 67 schools of public health, 127 public health programs, and 16 standalone baccalaureate programs. CEPH's 2019 training and technical assistance events reached 94% of accredited SPH, 86% of accredited PHP, and 63% of accredited SBP. CEPH's events, not including the Accreditation & Education Forum, reached:

- 1,087 total attendees
- 291 units (including accredited, applicant, and inquirer)



Technical Assistance (TA)

TA webinars have been an important tool for educating schools and programs about the accreditation criteria. In 2019, CEPH hosted four TA webinars on topics including data collection, curriculum, and concentration competencies.

All TA webinars are free, recorded, and made available on the CEPH website.

Pre-Application Orientation Webinar

The Pre-Application Orientation Webinar (P-AOW) is compulsory for units prior to sending an Initial Application Submission (IAS) to begin the accreditation process. The first three P-AOW offerings of the year were one-hour webcasts that provided an overview of the procedures and substantive requirements associated with beginning the accreditation process. CEPH staff presented information, and attendees could ask individual questions. CEPH offered two versions (one for SBP and one for PHP units) given that the application requirements differ. Units pursuing accreditation in the SPH category work one-on-one with CEPH staff given their individualized needs.

In summer 2019, staff developed a new delivery method for the P-AOW. It is now held in three parts:

- 1. Pre-recorded CEPH introduction (the same for all units)
- 2. Pre-recorded walk through of the IAS (SBP and PHP versions)
- 3. Live session with Q/A opportunity (SBP and PHP versions)

The pre-recorded elements are always available on the CEPH website, and the first redesigned live P-AOWs were offered in November 2019.

Accreditation Orientation Workshops

In 2019, CEPH hosted two Accreditation Orientation Workshops (AOW) on March 18-19 and August 1-2. These events were comprehensive sessions on the accreditation revised criteria and featured simultaneous sessions for representatives of accredited units and units pursuing initial accreditation.

Sessions covered CEPH procedures, focusing on the procedures most relevant to each group of stakeholders, but devoted the majority of the two-day agenda to a detailed examination of the expectations associated with each of the accreditation criteria. The workshop also included a networking reception and opportunities for participants to share challenges and insights with one another.

Site visitor refresher webinars

The site visitor refresher is a one-hour webinar that provides an update on site visit processes and protocols. In 2019, the webinar also discussed observations from the first year of site visits using the 2016 Accreditation Criteria and common questions on key criteria areas. The webinar is held twice a year, at the beginning of each site visit season. Site visitors scheduled for the upcoming season are required to attend, either by participating in the live webinar or by listening to the recording on their own.

Training and Technical Assistance

2019 Accreditation & Education Forum

Overview

In July 2018, CEPH staff conducted a survey to collect stakeholder feedback and opinions on training and technical assistance resources. The survey received 102 responses, and 82% of respondents expressed interest in attending a new one- to two-day, in-person event focused on accreditation and associated curricular and pedagogical areas. In response to this demand, CEPH hosted the first *Accreditation & Education Forum* on November 2 in Philadelphia, PA.

Attendees included 216 individuals representing accredited, applicant, and interested schools and programs. The Forum included presentations from over 50 public health faculty and higher education experts on topics including public health practice experiences, integrating faculty scholarship and practice activities into the classroom, holistic approaches to diversity, cultural

competence and inclusion, engaging online students, an overview of recently published research and data on public health student enrollment, program evaluation and data, and the landscape of bachelor's and doctoral public health education. These sessions included a variety of formats such as panels, workshops, and fireside chats.



Roderick King, MD, MPH, from the University of Miami, delivered the keynote address. His presentation, "Leading Change in Public Health Education: Building the Next Generation of Public Health Leaders," highlighted the challenges of educating students in a time of great change and offered change management principles to inform and empower faculty to lead their schools and programs through this change.

The Forum also provided opportunities for attendees to network with faculty from institutions with similar interests. Lunch tables were organized by varying topics, such as online programs, units

with bachelor's education, and schools of public health, to allow for focused networking and discussion. CEPH also hosted a networking reception at the end of the day.

Looking ahead

Feedback provided by the participants after the Forum was overwhelmingly positive. One respondent stated that the Forum "...provided me the opportunity to reflect more on enhancement and growth opportunities for my public health programs." When asked to identify the single most valuable thing learned at the Forum, many respondents called out the importance of connecting and communicating with other schools and programs.

Based on the success of the event, the Council acted to make the Accreditation & Education Forum a biennial event, with the next being offered scheduled in conjunction with the APHA 2021 Annual Meeting.



2019 Site Visits

On-site evaluation visits by teams of qualified reviewers are the primary basis by which the CEPH governing body is informed about the schools and programs it accredits. Typically, teams arrive on site the evening before the visit and spend two or three days interviewing university officials, administrators, program faculty, students, alumni, and community partners. Teams also review documents and view facilities and resources. The last component of the visit is an exit briefing. During 2019, CEPH conducted visits at the following 32 schools and programs:

CEPH Logo Update

In November 2019, the CEPH logo underwent a minor update. The goal of the update was to improve the usability of and modernize the logo. CEPH's logo represents the collaborative, systems approach that is so highly valued in the public health profession. The three interconnected rings are reflective of CEPH's many relationships within public health and higher education.

CEPH Trademark

The Council on Education for Public Health (CEPH) has registered its name and acronym with the United States Patent and Trademark Office.

The federal registration symbol (®) or the phrase "Registered in U.S. Patent and Trademark Office" will now appear at least once on 1) all advertising and printed materials bearing the CEPH name; 2) in packaging in which any goods are sold or shipped; 3) any tags or labels applied or affixed to the goods upon which the mark is used; and 4) all website pages featuring the mark. Failure to use any of these notices may preclude a monetary recovery in an infringement suit. The registration is valid until September 24, 2029.



Applications

The Council reviewed 21 requests from educational institutions desiring to begin the accreditation evaluation process in 2019.

These schools and programs do not appear on the published CEPH list until after a site visit and a favorable decision is made about accreditation. Applicants have up to two years to undertake a selfstudy process and submit the document; the on-site visit is conducted about five months later. However, applicants may be ready to proceed more quickly and may negotiate earlier site visit dates.

US Department of Education Recognition

CEPH is recognized by the United States Department of Education (USDE). Recognition by USDE is essential to establishing eligibility of accredited schools and programs for certain federal funds. Recognition requires that an accrediting agency meet specific criteria and guidelines and that there be a periodic review and recertification of the qualifications of an accrediting body.

Recognition is conferred for periods up to five years. CEPH was reviewed in July 2019 and, following this review, the Secretary of Education notified CEPH that its recognition had been extended for a five-year period with no required interim reporting.



Negotiated Rulemaking

In 2019, CEPH's executive director served as a nonfederal negotiator on the US Department of Education's Accreditation & Innovation Negotiated Rulemaking Committee, negotiating specific federal rules on topics such as accreditor recognition requirements, distance education requirements, and some related federal financial aid issues. Dr. King was one of 15 negotiators, and the only person representing specialized accreditation. She was able advocate for key issues related to the field. The committee came to a consensus on all issues for the first time in a decade.

Participation in ASPA

CEPH was a founding member and continues as an active participant in the Association of Specialized and Professional Accreditors (ASPA), a national organization of approximately 60 specialized accrediting agencies that provides membership services, including professional development for staff, and advocates on behalf of the specialized accrediting community.

CEPH's executive director participates actively in ASPA and has served on several committees and task forces in past years. She served as chair of



ASPA's Board of Directors from May 2014 through May 2017. She served as ASPA's treasurer in 2017-2019. In 2018, she became the chair of the Education Policy Committee, which closely monitors policy developments related to the US Department of Education as well as the Council on Higher Education Accreditation.

As chair of the Education Policy Committee, Dr. King serves as a liaison for programmatic accreditation with the US Department of Education and congressional staff to ensure that the perspectives of specialized and professional accreditors are considered in national policy discussions.

CEPH's deputy director currently serves on the ASPA board. Additionally, Ms. Mulvanity has served as chair of the ASPA Professional Development Committee. In this role, she planned and led educational programming for ASPA members at their bi-annual meetings. ASPA is the primary source for professional development among the staff of programmatic accreditors, and CEPH encourages participation in these educational opportunities for all staff.

CEPH is proud to be a national leader in specialized and professional accreditation.

Presentations at partner organizations

CEPH staff also presented in-person at meetings across the country and internationally on accreditation-related topics and matters. In 2019, CEPH staff presented at the ASPPH Annual Meeting . the National Environmental Health Association, the Society of Public Health Education, the Association for Prevention, Teaching,, Research Council of Graduate Programs, and the ASPPH Academic Regional Meeting in Asia.

Looking Ahead to 2020

2020 promises to be a busy and exciting year for CEPH. While the COVID-19 outbreak has affected the ways in which CEPH and its stakeholders do business, the Council is committed to continuing to serve our schools and programs while maintaining the safety of our staff and volunteers.

CEPH will continue to focus on providing technical assistance to schools and programs as they implement new curricula. Training activities will include multiple offerings of the Accreditation Orientation Workshop, the Pre-Application Orientation Webinar, and quarterly technical assistance webinars. As part of the criteria implementation effort, CEPH will release a report in the fall 2020 highlighting the effects and trends of the implementation of the 2016 criteria on public health schools and program.

Additionally, CEPH will begin an overhaul of its site visitor training. The training will be moved to a fully online delivery format with implementation scheduled for early 2021.
