Annual Reporting Requirements

The Council on Education for Public Health (CEPH) is a private non-profit corporation established in 1974 by the American Public Health Association (APHA) and the Association of Schools of Public Health, now known as the Association of Schools and Programs of Public Health (ASPPH). The articles of incorporation were adopted by the two associations, which became the original corporate members of the new organization. The articles specified CEPH's purposes as follows:

- (a) Improving the quality of education in public health schools, institutions, and programs through accreditation, certification, approval, and related activities which publicly attest compliance with defined standards; including particularly the accreditation of graduate schools of public health.
- (b) Otherwise encouraging improvement in the quality of education in public health through conduct of research, provision of consultation, distribution of publications, support of demonstrations, definition of standards, development of sanctions, sponsoring of examinations, and other appropriate means related to accreditation, certification, and approval activities.
- (c) Assuring an independent mechanism for the conduct of these accreditation and related activities under joint sponsorship of professional and educational organizations comprising the corporation membership.

The articles of incorporation ascribed broad powers and responsibilities to the governing body of the newly established organization. One of the obligations specified in the charter was a requirement that CEPH annually call a meeting of the corporation membership at which duly designated representatives of those organizations would meet with the Council to receive its annual report. This report, which reviews the activities of calendar year 2021, is submitted in response to that requirement.

About CEPH

The Council on Education for Public Health is a private, non-profit corporation chartered under provisions of the District of Columbia Non-Profit Corporations Act. It is recognized by the Internal Revenue Service as a 501(c)(3) organization and by the State of Maryland as an organization exempt from local income and sales taxes. No organizational or structural changes took place during 2021 that would affect this status.

Dear Friends and Colleagues,

The Council on Education for Public Health is pleased to share its 2021 annual report, which shows a growing demand for quality education in public health. Throughout the past year, the public health community continued to combat the COVID-19 pandemic. The Council was continuously impressed by the work undertaken by public health faculty, researchers, and students in response to the pandemic throughout 2021.

This was another busy and eventful year for CEPH! The Council continued to conduct virtual site visits in early 2021. With the availability of vaccines, CEPH staff and volunteers were able to begin traveling again and conducted the fall 2021 site visit season in person.

In 2021, the Council conducted its 5-year review and adopted revisions to the *Accreditation Criteria for Schools and Programs of Public Health* and the *Accreditation Procedures*. These revisions were not substantive, but intended to clarify language, make intended requirements implicit, remove unintended duplication, and streamline language, where possible.

CEPH has also continued to focus on providing technical assistance to schools and programs. Priority activities included multiple online offerings of the Accreditation Orientation Workshop, regular technical assistance webinars, and presentations at the meetings of our partner organizations.

We sincerely appreciate the engagement of the academic and practice community alike in our efforts this past year. Achieving our mission of assuring quality education in public health is only possible with the support of our many partners. The Council would also like to thank its dedicated volunteers who contribute countless hours to the accreditation process. This has been a challenging year, but we are very grateful for and proud of the work of our public health colleagues. The future of public health is brighter because of these efforts.

We hope you find this report informative and comprehensive. Questions and comments are always welcome.

Board of Councilors

The articles of incorporation establish a 10-member Board of Councilors as the governing body of CEPH. Members of the governing body are appointed either singly or jointly by the two corporate members.

APHA appoints three members to the Council, and those representatives are expected during their tenure as councilors to be "primarily involved in the practice of public health or in the conduct of related health services."

ASPPH appoints three members, and its delegates are to be "drawn from the faculty, administration or student body of schools of public health."

The remaining four councilors are jointly appointed by the corporate members on the recommendation of the CEPH governing body.

Two of these positions represent the interests and concerns of the general public; public members may not be employed by an academic institution that has a school or program of public health. The remaining two positions represent the programs accredited by CEPH. These candidates are nominated after broad solicitation of relevant organizations. The Executive Committee met four times in 2021 via Zoom. The committee functions as a finance committee; it performs regular monitoring of CEPH financial matters, adopts annual fee schedules, and initially reviews and assists with budget development. The Executive Committee is also empowered to act for the Council between regular CEPH meetings; it considers substantive change notices and other routine accreditation-related business, freeing the Council meetings for discussion of substantive matters. At its November 2021 meeting, the full Council elected, by secret ballot, the officers who will serve on the Executive Committee in 2022.

Site Visitor Training Activities

Graduate Level Site Visitor Training

In 2021, a cohort of 28 graduate-level site visitors completed their training with a two-hour live session in March, following completion of an extensive set of online training modules. CEPH staff hosted the training, which focused on application of skills and knowledge of the criteria. CEPH staff provided trainees an exercise workbook and provided time during the training to work through scenarios and examples.

Attendees were sent an evaluation at the end of the training. When asked to rank confidence in understanding of accreditation processes, 100% agreed or strongly agreed. When asked to rank confidence in understanding of the CEPH accreditation criteria, 96% agreed or strongly agreed, and 4% (n=1) were neutral.

SBP Site Visitor Training

CEPH also trained eight new SBP site visitors. Trainees attended a live webinar session that focused on the site visit process, criteria expectations, and report writing.

New Chair Training

In addition to training new site visitors, CEPH trained two existing site visitors to be site visit chairs. CEPH began engaging new site visitors and newly trained chairs immediately, all of whom have completed site visits successfully.

Management & Administration

Staff

Laura Rasar King, EdD, MPH, MCHES serves as the Executive Director of CEPH. Dr. King is a frequent speaker on higher education, accreditation, academic public health, and public health workforce issues. She represents CEPH at national and international public health and accreditation meetings.

Mollie Mulvanity, MPH, CAE, serves as the Deputy Director of CEPH. During her years at CEPH, she has visited more than 100 public health schools and programs while providing consultation or staffing accreditation reviews. Ms. Mulvanity serves on the board of the Association of Specialized & Professional Accreditors. She is also a frequent presenter at professional meetings on the evolution of quality assurance in public health higher education, particularly in relation to MPH curricula.

Kristen Varol, MPH, PMP, CHES, serves as the Director, Accreditation Services. Ms. Varol has provided consultation to and staffed accreditation reviews for schools and programs across the US and internationally. She is a member of ASPPH's Data Committee and supports efforts to streamline data collection and sharing between the two organizations.

Nicole Williams, MPH, PMP, serves as the Director, Accreditation Operations. During her years at CEPH, Ms. Williams has assisted in the development and implementation of standalone baccalaureate program accreditation. In 2019, she managed the development and implementation of the Accreditation & Education Forum.



Alexandra DiOrio, MPH, CHES serves as a Senior Accreditation Specialist. Her duties include leading CEPH data collection initiatives in addition to managing the accreditation review process and serving as the coordinator for accreditation visits.

Accreditation Specialists Emily Albers, MPH, CPH, Zeinab Bazzi, MPH, and Julia Konner, MPH, CHES, and Accreditation Coordinators Cheyenne Barger, MPH, Galvin Jack, MPH, and Cara Damico Smith, MPH carry out tasks to ensure that the accreditation review process for schools and programs proceeds smoothly. Their duties include managing the accreditation review process, serving as coordinators for accreditation site visits, editing and preparing sections of site visit team reports, developing training materials, conducting training sessions, and responding to stakeholder inquiries.

Accreditation Program Assistant Jaquis Williams, BSPH, manages administrative and financial support. Her duties include supporting the organization's financial operations, drafting and sending accreditation correspondence, supporting senior staff in data collection and maintenance, maintaining contact information for school and program stakeholders, and supporting staff with logistics and registration for online trainings and webinars.

Management & Administration (cont.)

Sources of Financial Support

The Council's income derives from a combination of contributions and fees. During FY 2021 (July 1-30), APHA contributed \$108,900 in unrestricted funds to CEPH. Accredited schools of public health, public health programs, and standalone baccalaureate programs approximately \$1,373,778 in annual fees. Additional fees are charged when a school or program undergoes its periodic reevaluation, begins the applicant process, or seeks consultation. Total revenues during 2021 from contributions, fees for specific services, interest, and miscellaneous sources amounted to \$1.735.873 (including reimbursement for travel expenses of site visitors and consultants).

Budgeting and Financial Planning

The Council adopted a budget for calendar year 2021 in the amount of \$1,845,360. Budget planning takes into account anticipated review workloads and expected inflation, as well as the organization's policy about maintaining reserves. Actual income for the year was slightly lower than projected at \$1,735,873, due to the lower level of reimbursable travel. Actual expenditures for the year


were significantly lower than budgeted, approximately \$1,642,698 due to the pause on travel necessitated by the pandemic for a portion of the year. CEPH ended the year with approximately \$1,400,000 in cash reserves amounting to approximately 71% of the operating expenses for the year. The Council follows a policy of maintaining reserves equal to at least six months of operating expenses.

The APHA Executive Board approved a new funding agreement for July 1, 2021 to June 30, 2022 of \$110.510.

Each summer, the CEPH Executive Committee establishes a fee schedule that will be applicable for the following year. The annual support fees for accredited schools and programs increased slightly for 2022. Applicant, accreditation, and consultation fees remained the same as the previous year.

Audit of CEPH Accounts

The accounting firm of Neuman, Pollack and Associates, P.A. was retained to conduct an independent audit of CEPH's financial records for 2021. A copy of the audited financial statement is a part of this annual report to the corporate members.



Training and Technical Assistance

In 2021, CEPH offered a range of live, synchronous training and technical assistance events. Most offerings are also available in perpetuity for viewing as asynchronous webcasts. Due to pandemic-related restrictions, all 2021 trainings were delivered online.

Total attendees: >1,200

Distinct attendees: 828

As of December 31, CEPH accredited a total of 228 units: 68 schools of public health, 140 public health programs, and 20 standalone baccalaureate programs. CEPH's 2021 training and technical assistance events reached the following units:

99% of schools of public health

84% of public health programs

55% of standalone baccalaureate programs

Technical Assistance (TA)

TA webinars are an important tool for educating schools and programs about the accreditation criteria.

All TA webinars are free, recorded, and made available on the CEPH website.



Pre-Application Orientation Webinar (P-AOW)

The P-AOW is compulsory for units prior to sending an Initial Application Submission (IAS) to begin the accreditation process. CEPH offers two versions (one for SBP and one for PHP units) given that the application requirements differ. Units pursuing accreditation in the SPH category work one-on-one with CEPH staff given their individualized needs.

The P-AOW includes three parts:

- Pre-recorded CEPH introduction (the same for all units)
- Pre-recorded walk through of the IAS (SBP and PHP versions)
- 3. Live session with Q&A opportunity (SBP and PHP versions) offered quarterly

In 2021, a total of 72 representatives from 46 prospective applicant units attended the four live sessions (February, May, August, and November).

Accreditation Orientation Workshop (AOW)

In 2021, CEPH hosted seven online AOW sessions for accredited and applicant units in March, April, June, July, and August. These events were comprehensive sessions on the accreditation criteria.



The seven sessions were offered virtually due to the COVID-19 pandemic. Sessions covered CEPH procedures, focusing on the procedures most relevant to each group of stakeholders, but devoted a majority of the two-day agenda to a detailed examination of the expectations associated with the accreditation criteria. The workshop also included breakout sessions to review sample competencies from each participant and opportunities for participants to share challenges and insights with one another.

Site visitor refresher webinars

The site visitor refresher is a one-hour webinar that provides an update on site visit processes and protocols. The webinar is held twice a year, at the beginning of each site visit season. Site visitors scheduled for the upcoming season are required to attend, either by participating in the live webinar or by listening to the recording on their own.

2021 Site Visits

Evaluation visits by teams of qualified reviewers are the primary basis by which the CEPH governing body is informed about the schools and programs it accredits. Typically, teams arrive on site the evening before the visit and spend two or three days interviewing university officials, administrators, school and program faculty, students, alumni, and community partners. Teams also review documents and view facilities and resources. The last component of the visit is an exit briefing.

On March 13, 2020, CEPH began a period of social distancing and compliance with stay-at-home orders at the local, state, and federal levels due to the COVID-19 pandemic. CEPH adopted a Virtual Site Visit Policy and Disclosure Statement on April 23, 2020. From June 2020 through June 2021, all site visits took place virtually via Zoom. During 2021, CEPH conducted visits with the following 41 schools and programs:



Applications

The Council reviewed seven requests from educational institutions desiring to begin the accreditation evaluation process in 2021.

These schools and programs do not appear on the published CEPH list until after a site visit and a favorable decision is made about accreditation. Applicants have up to two years to undertake a self-

study process and submit the document; the site visit is conducted about five months later. However, applicants may be ready to proceed more quickly and may negotiate earlier site visit dates.

Accreditation Matters

US Department of Education Recognition

CEPH is recognized by the United States Department of Education (USDE). Recognition by USDE is essential to establishing eligibility of accredited schools and programs for certain federal funds. Recognition requires that an accrediting agency meet specific criteria and guidelines and that there be a periodic review and recertification of the qualifications of an accrediting body.

Recognition is conferred for periods up to five years. CEPH was reviewed in July 2019 and, following this review, the Secretary of Education notified CEPH that its recognition had been extended for a five-year period with no required interim reporting.



Participation in ASPA

CEPH was a founding member and continues as an active participant in the Association of Specialized and Professional Accreditors (ASPA), a national organization of approximately 60 specialized accrediting agencies that provides membership services, including professional development for staff, and advocates on behalf of the specialized accrediting community.

CEPH's executive director, Dr. Laura Rasar King, participates actively in ASPA and has served on several committees and task forces in past years. She served as chair of ASPA's Board of Directors from May 2014 through May 2017. She served as ASPA's treasurer in 2017-2019. In 2018, she became the chair of the Education Policy Committee, which closely monitors policy developments related to the US Department of Education as well as the Council on Higher Education Accreditation.

As chair of the Education Policy Committee, Dr. King serves as a liaison for programmatic accreditation with the US Department of Education and congressional staff to ensure that the perspectives

of specialized and professional accreditors are considered in national policy discussions.



CEPH's deputy director, Ms. Mollie Mulvanity, currently serves as ASPA's treasurer. ASPA is the primary source for professional development among the staff of programmatic accreditors, and CEPH encourages participation in these educational opportunities for all staff.

CEPH is proud to be a national leader in specialized and professional accreditation.

Collaboration with partner organizations

CEPH staff regularly collaborate with partner organizations to advance the field of public health education.

CEPH's executive director serves on a number of committees and task forces, including as chair of the Governance 2.0 Task Force for the Society of Public Health Education, as the primary CEPH representative on the Council on Linkages Between Academia and Public Health Practice, and as a representative of specialized accreditation on the Student's Right To Know Task Force for the Higher Learning Commission.

CEPH staff also presented at national and international meetings on accreditation-related topics and matters. Dr. King and Ms. Mulvanity presented at several sessions of the ASPPH annual meeting, including one on professionalization of public health. They also presented at webinars for AAPHP and APTR.

CEPH's director of accreditation services, Ms. Kristen Varol, presented at ASPA's spring conference. Ms. Varol presented on staff support during the accreditation application process.

CEPH staff also attended meetings of APHA, ASPPH, AAPHP, The Mid Atlantic Partnership, and APTR's Council of Graduate Programs.

Looking Ahead to 2022

2022 promises to be a busy and exciting year for CEPH. We will continue to monitor the COVID-19 pandemic and transition our site visit teams back on the road. CEPH will continue to implement in-person follow-up visits for all virtual site visits. The Council will add four new members in 2022, including our first representative from a standalone baccalaureate program. Additionally, the Council will begin discussions related to revising the Accreditation Criteria for Standalone Baccalaureate Programs.

CEPH will continue to focus on providing technical assistance to schools and programs. Training activities will include the first in-person offering of the Accreditation Orientation Workshop since 2019, the Pre-Application Orientation Webinar, and regular technical assistance webinars. Given that the Council revised the SPH and PHP accreditation criteria in 2021, we will provide updated training to volunteer site visitors via a fully online training platform. Additionally, CEPH will submit its petition for continued recognition to the US Department of Education.
